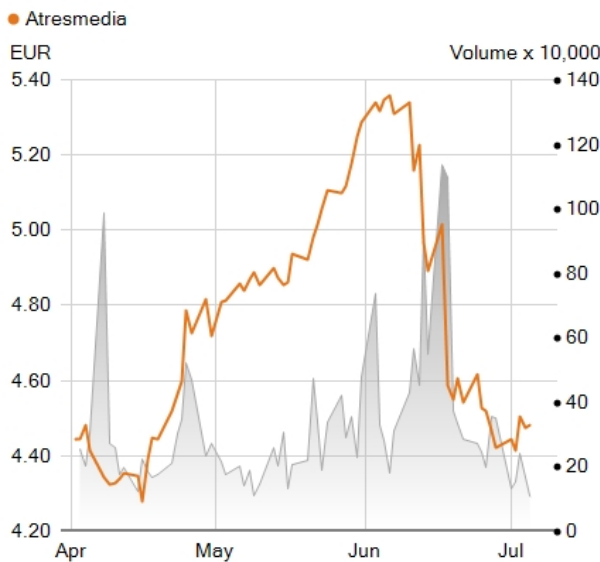


Company Information
