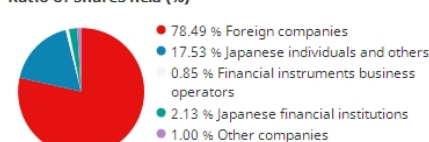

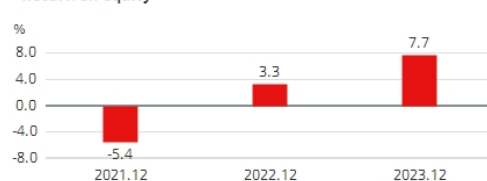

Ratio of shares held (%)



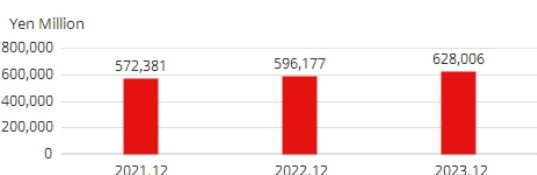
Return on equity
