

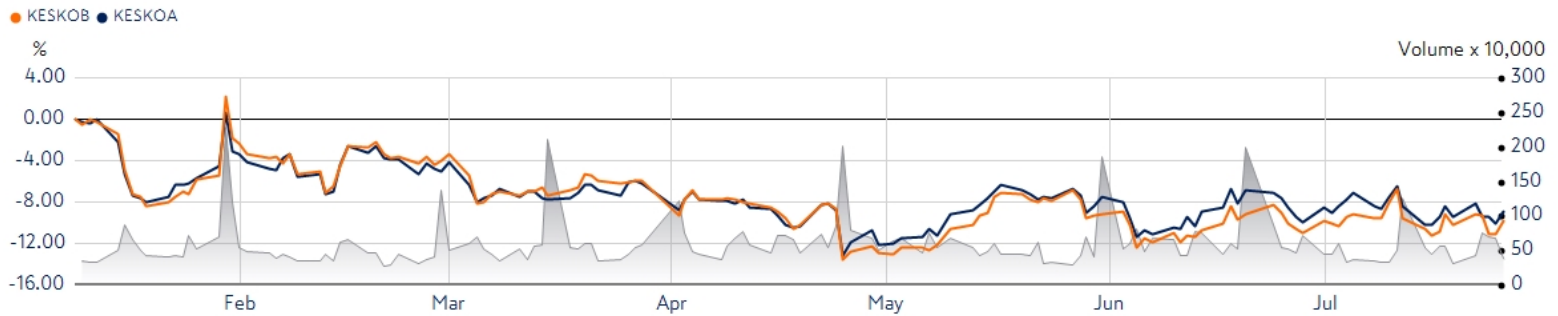
Company Presentation

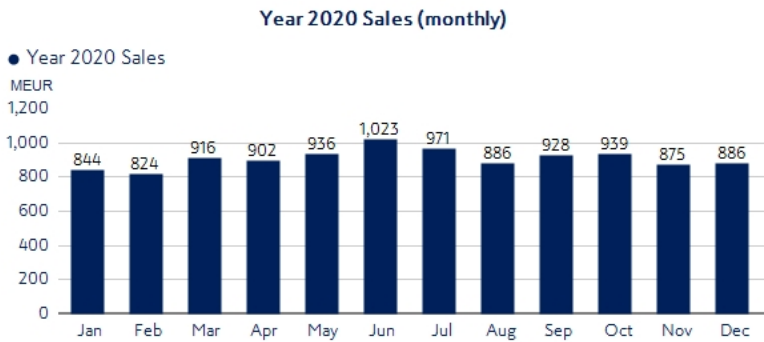
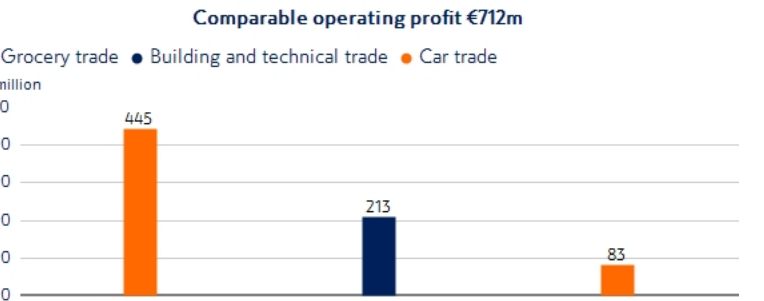
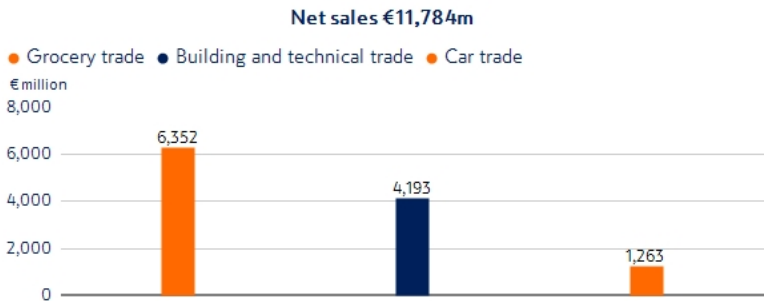
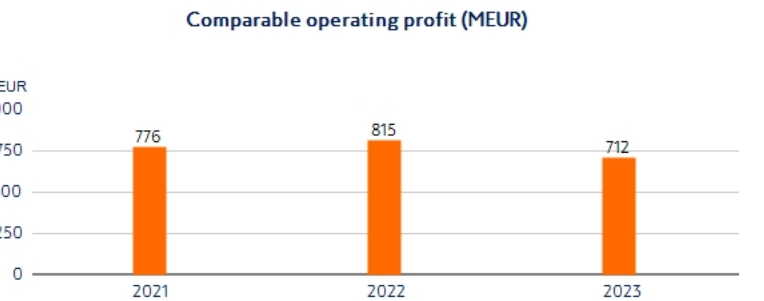
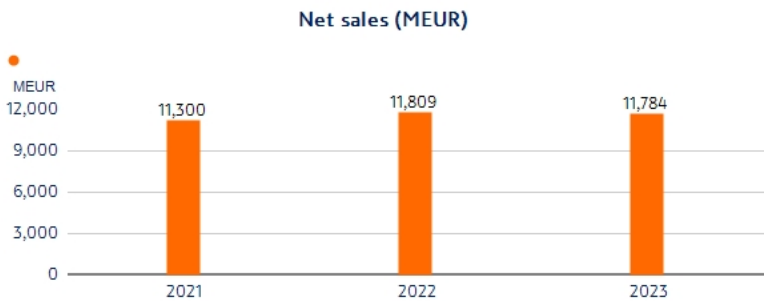
Kesko has around 1,800 stores in Finland, Sweden, Norway, Estonia, Latvia, Lithuania and Poland and Denmark.

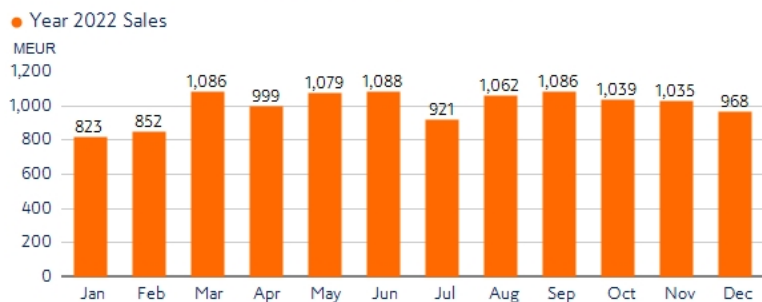
Kesko's shares are listed on Nasdaq Helsinki. The company's domicile and main premises are in Helsinki.



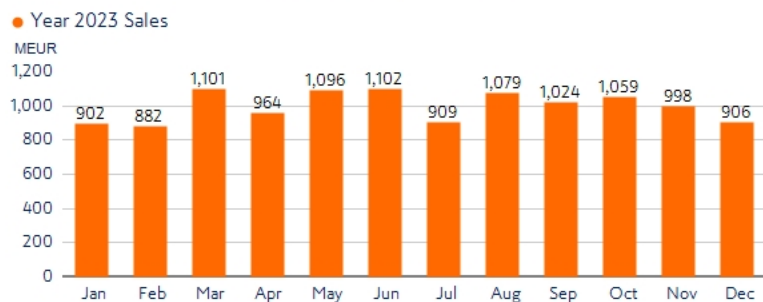
