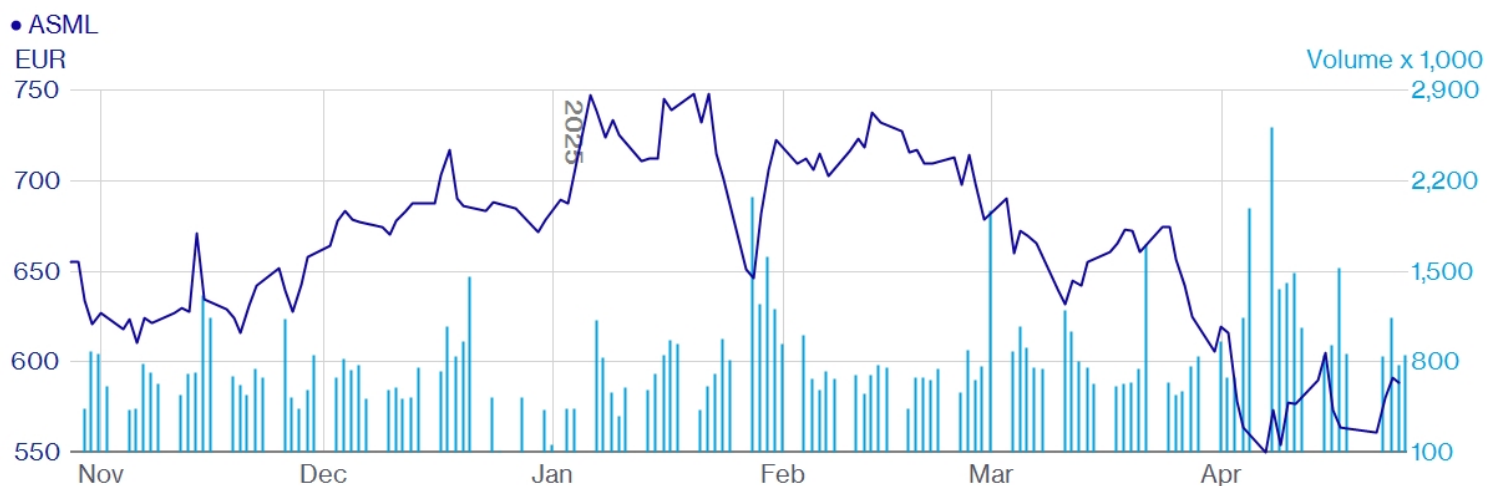

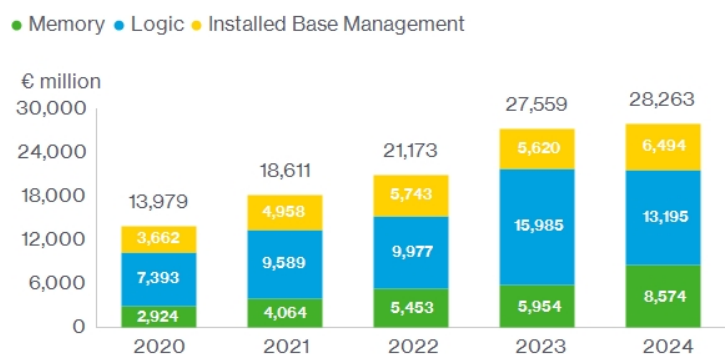

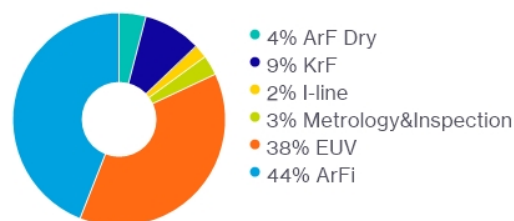

Total net sales € million by End-use

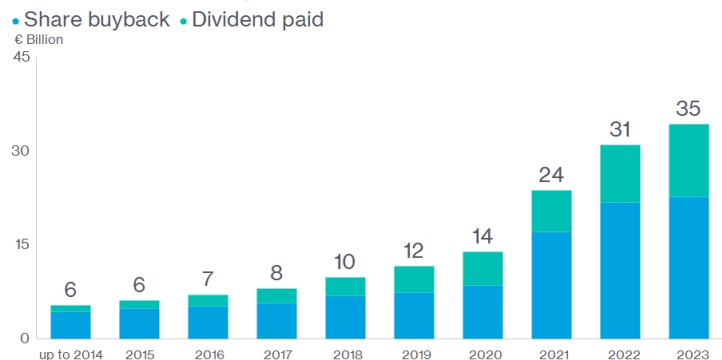

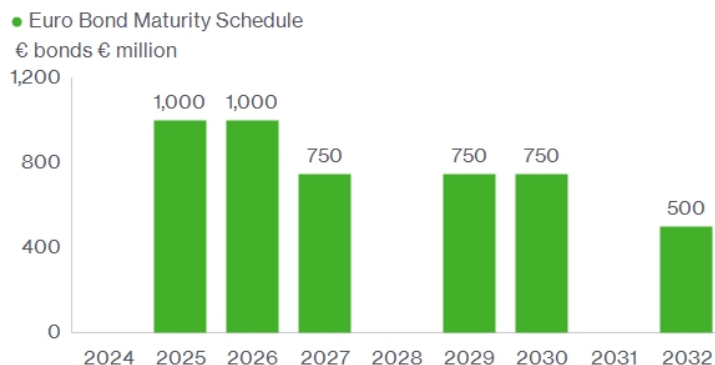
